


## LUCY FRANKS-DRUMMOND'S RECORDS

Lucy was born Lucina Francisco de Jesus on January 31, 1896, in Hilo, Territory of Hawaii.



# LUCY FRANKS-DRUMMOND'S RECORDS

## Her certificate of Baptism reads:

*"Certificate of Baptism of the Church of Saint Joseph, Hilo, Hawaii. This is to certify that Lucina de Jesus, child of John Francisco de Jesus & Alalia Francisco de Jesus, born in Hilo, Hawaii on the 31st day of January 1896, was baptised on the 10th day of May 1896 according to the rites of the Roman Catholic Church by the Rev. Father Maxime Andre, the sponsors being Manuel Gomes. As appears from the Baptismal Register of this Church #3231 dated March 11, 1946."*

In 1901, Lucy started Central Grammar School at age 5 in Honolulu, graduating in 1909.

From 1909-1913 she attended McKinley High School in Honolulu, Territory of Hawaii.

From 1913-1914 she attended The Territorial Normal & Training School in Honolulu, Territory of Hawaii, earning a Diploma in Elementary Teaching.

Lucy took an additional 23 educational credits from the University of Hawaii. On January 1, 1925, she received her Elementary Life Certificate from the Territory of Hawaii.

In 1953 she applied for reinstatement. She received her SDA Teacher's Certificate on September 1, 1956, and continued teaching until retirement in the early 1960s.

## Her marriage:

Lucy Franks married Robert Drummond on Saturday, **November 29, 1924**, at Epiphany Church, in Honolulu, Hawaii. Ceremony was performed by Elmer S. Freeman, Rector. The published announcement read:

*"Miss Lucy Franks, member of the faculty of the Waikiki government school, of 1220 Tenth avenue, & Robert Drummond were married at the Epiphany Episcopal church, Tenth & Pahoa avenues, Saturday by the pastor, Rev. Elmer S. Freeman. The witnesses were Mr. & Mrs. Frankie Franks, brother & sister-in-law of the bride."*

### **Her divorce:**

Lucy and Robert were divorced on **July 21st, 1925** – after 35 weeks & 6 days of marriage; just 10 weeks prior to the birth of their child – by Judge John R. Desha in the First Circuit Court of the Territory of Hawaii. The decree read:

*“...praying that the bonds of matrimony heretofore existing between them, the said Lucy Drummond, libellant, & Robert Drummond, libellee be dissolved by reason of the alleged failure to provide suitable maintenance of said libellee.... This decree to take effect from & after the 22nd day of July 1925. It is further ordered that the libellee pay to the libellant the sum of \$290.00 in full for all alimony due or to become due to said libellee for the support of herself & the unborn child of the parties hereto, & which said sum is also in full for all attorney’s fees & costs of this proceeding.”*

### **The published announcements read:**

*“DIVORCE SUIT FILED — Lucy Drummond filed a divorce libel in the court of domestic relations today against Robert Drummond, charging non-support. DIVORCE GRANTED — On the ground of failure to provide, Lucy Drummond has been granted a divorce from Robert Drummond by Judge John R. Desha of the court of domestic relations. Drummond has been ordered to pay \$209 gross alimony.”*

### **Her daughter:**

On September 29, 1925, Lois Ann Drummond was born in Hilo, Hawaii. At age 3 (1929), Lois was placed in the Happy Hours Nursery School in Honolulu. At 4, she sat in on her mother's class & started 1st grade at Lunalilo Elementary School. Lois attended Lunalilo from 1930 to 1932, completing the 2nd grade there.

### **Other life events:**

On March 12, 1932, Lucy was baptized into the Seventh-day Adventist Church by Elder Heaton, Margie Maket's father.

Her daughter, Lois, was then placed in Hawaiian Mission Academy Elementary School where she attended from 1932 to 1938, completing grades 3 through 8 there. From 1939 to 1941 Lois attended Hawaiian Mission Academy.

In September 1941, Lucy took a sabbatical from teaching & moved to Alameda, California, for 1 year. Lois attended Golden Gate Academy in Oakland, California, for her senior year (1941-1942). At the age of 16, Lois went to Pacific Union College in Angwin, California, and Lucy returned to Hawaii to teach.

Lois attended PUC from 1942 to 1946, earning a BA in English June 1946. She married Al Stoops on September 5, 1946.

### **Her death:**

**November 22, 1966** – Lucy Franks Drummond, born Lucina de Jesus on January 31, 1896, in Hilo, Territory of Hawaii to John & Eulalia Francisco de Jesus “Franks,” age 70, died of kidney cancer metastases in Eugene, Oregon.
